Councilman Craig Doris reported he will be meeting with Superintendent Craig Collins and Attorney Dale Pike to try to figure out ownership of substations.

Councilwoman Christine Birney-Carter talked about possibly implementing a 'yard of the month' during the spring/summer months. This will be revisited in the spring.

Councilwoman Janet Shapland made the motion to amend the agenda, adding longevity bonus plan to D. under new business, Councilman Craig Doris seconded, yeas by all, motion carried.

Superintendent Craig Collins reported they will start trying to reach the residents that haven't responded to the lead and copper survey sometime in mid-October.
